The new AVG law

As of May 20, 2018, in accordance with the law, we are required to inform you about the following: AVG

The protection of your personal data: Your personal data is treated with the utmost care and is protected. We use and retain personal information only for the purpose for which you provide it to us. We act in accordance with the General Regulation Data Protection (AVG) and the Telecommunications Act. The personal data provided to us via our website and email, will never be provided to third parties.

What data do we process?

When you fill in the contact form, then we have the following information:

- Your name
- Your email address
- Your phone number
- Your address and postal code

When you send us an e-mail, we know:

- Your name or the name you entered in your e-mail program
- Your email address
- Your telephone number (optional)

We use this information solely to respond to your message.

This information is stored by software in which the contact form is stored on our Web server and from there sent to our mailbox. This is done via an encrypted connection, which is to recognize the Green clasp and the designation <https://>for the URL.

When you book a rental boat through our website, then we have the following information:

- Your name
- Your address
- Your email address
- Your phone number

We use this information only to communicate with you about the rental.
This information is stored in the booking system by 123Boeken.nl
If you do not wish to provide this information, you will not be able to rent our boats.

Cookies

This website makes use of cookies.

How long do we keep your personal data?

We will retain your personal data for longer than is necessary and solely for the purpose (s) for which you have provided us with it. When you rent a boat with us, an invoice is made. The tax administration states that these invoices are required to be kept for 7 years. It will then be destroyed within 6 months.

Withdrawal of your consent?

You can ask us at any time to present to you what personal information we have about you. You can ask us to delete what data we have about you. Send us a request by email at info@predator-fishing-holland.nl. We will then respond to your request within 4 weeks.

Security

The message traffic between your pc, phone or tablet and this website is via SSL/HTTPS. This means that the traffic is encrypted. This will prevent unwanted access by third parties. In addition, this website is monitored by security software. If, despite all the security measures, a data leak occurs, we will report this directly at the authorities.
